MINUTES

1. Call to order.

Mayor Roper called the meeting to order at 6:00 p.m. Council members present were Mayor Chuck Roper, Mayor Pro tem Bill Coleman, J. Fagner and Kelly Yarbrough. Jeff Linnstaedter was absent.

City Staff present were Joseph Pace and Monica Hendrix.

2. Discussion and possible action appointing the Lorena Tomorrow Committee.

Council was given the list of recommended citizens for the committee. There was discussion about the list and the citizens that may live outside the city limits. After discussion a motion was made by Bill Coleman and seconded Tommy Ross to approve the Lorena Tomorrow Committee. All in favor, motion carried.

3. Discussion and possible action on Ordinance 2020-0302-01 cancelling the May 2, 2020 General Election.

Monica Hendrix explained that the election is canceled due to no opposition on the ballot. A motion was made by Tommy Ross and seconded by Bill Coleman to approve the ordinance canceling the May 2, 2020 general election. All in favor, motion carried.

4. Discussion and possible action to relieve Knight Law Firm, LLP., of its role as City Attorney for the City of Lorena, Texas, but retain their legal services as outside counsel.

Joseph Pace informed council he would like to keep Knight Law Firm, LLP on retainer as outside counsel for PUC issues that are still pending. Bill Coleman motioned to relieve Knight Law Firm, LLP., of its role as City Attorney for the City of Lorena, Texas, but retain their legal services as outside counsel. J. Fagner seconded the motion. All in favor, motion carried.

5. Discussion and possible action on the City of Lorena to relieve the Knight Law Firm, LLP., of its role as City Attorney and disengage their legal services.


