

Statement of Nature of Emergency: On April 27, 2020, the Governor of Texas issued Executive Order GA 18 reopening certain segments of the economy, and on April 28, 2020, the McLennan County Commissioners Court approved extended its disaster order consistent with the Governor's Executive Order GA 18. The ordinance to be considered will continue the Mayor's Declaration of Disaster that was extended by the action of the City Council on April 20, 2020 until April 30, 2020, in conjunction with the McLennan County disaster order to be consistent with the executive order.
