1. Call to Order/Roll Call.

2. Citizens questions or comments.

At this time any person with business before the Council not scheduled on the agenda may speak to the Council. Comments are limited to three (3) minutes, and this time is not transferable. Under the Texas Open Meetings Act, the Council is prohibited from discussing, responding, or acting on any comments or items that have not been properly posted on the agenda. This forum is limited to a total of 30 minutes.

Local citizen Brandon Ford who lives at 605 Gibraltar spoke and is concerned about the tall grass behind his fence. He is under the impression that the city owns this property and wants to know

why it hasn't been mowed and feels that it is a fire hazard. Interim City Manager Kevin Neal will get with him after the meeting concerning the issue.

AGAINST: None


