Yarbrough stated the Booster Club will obtain liability insurance for the event. The Booster Club will get with the Chamber concerning the times. Mayor Tommy Ross had questions about security. Mayor also wanted to be clear that this event is sponsored by the booster club and not the Lorena ISD. Katrina George voiced concerns about social distancing and stressed the need to promote it and wear mask.

Motioned carried.


**10. Update by Interim City Manager on Robinson Water Contract.**


**11. Adjourn.**
