

PUBLIC NOTICE TO BIDDERS ADVERTISING THE PROJECT

Sealed bids addressed to the Honorable Mayor and City Council will be received at the office of Monica Hendrix, the City Secretary, City of Lorena, City Hall; 107-A S. Frontage Road I-35; Lorena, Texas 76655 until 10:00 AM; on Thursday, September 18, 2025 for the construction of the 2025 Street Improvements in the City of Lorena, Texas. The bids shall be labeled:

Bids must be submitted on the Bid Form provided and must be accompanied by a cashier's check, certified check or acceptable bidder's bond payable without recourse to the City of Lorena, Texas in an amount not less than five (5) percent of the bid submitted as a guarantee that the bidder will enter into a contract and execute a Performance Bond and a Payment Bond within ten (10) days after the notification of the award of the contract.

The bids will be publicly opened and read aloud in the Council Chambers in Lorena City Hall; 107-A S. Frontage Road I-35; Lorena, Texas 76655 at 10:00 AM on Thursday, September 18, 2025. The City Council will officially review the bids at a regularly scheduled meeting and award the contract as soon thereafter as practical.

The City of Lorena reserves the right to accept or reject any and all bids, as the best interest of the City may require, and to waive any informality in bids received.

This project includes, but is not limited to approximately 1,600 LF of ROW clearing, 3,150 SY of 7.5" depth roadway excavation, 3,150 SY of geogrid and 6" crushed limestone base installation, 2,920 SY of 1.5" Type D HMAC, installation of 18" Class IV RCP and slope end treatments, concrete driveway installation, installation of object markers, signage, minor channel grading, revegetation, SWPPP, traffic control, etc.
